Subject: SSCSD WWTP RELOCATION

Date: NOVEMBER 14, 2022

In an effort to avoid controversy within our community and provide input to Dudek and the San Simeon Community Services District for the relocation of the Waste Water Treatment Plant (WWTP), the San Simeon Chamber's Board of Directors authorized an outreach to the community to garner support for a possible solution.

We recognize that many residents are concerned about escalating costs and resulting utility fees and division within our community, and we hope this information will be beneficial in developing a solution that will benefit the community now and into the future.

We wish for the ultimate solutions to be regional in nature, as in the past, by supporting California State Parks and the Hearst Corporation to the North, and that it might provide a long term solution for Cambria's water reclamation project to the South.

We have reviewed the available information and believe the two sites identified as "A" and "X" have the most potential and set forth our reasoning below following the screening analysis.

- With the California Coastal Commission (CCC) requirement to move the WWTP
 away from the coastal zone, we believe both of these sites meet that edict. It will
 help improve visitor access to the beach and recreational activities and reduce and
 minimized the visual impact, while proper screening will make the new sites
 virtually undetectable.
- 2. Reviewing work performed by Padre Associates, Inc. in March 2019 on site "A", we believe that the cultural impact will be minimal and can be mitigated. We also believe, based on previous walk throughs, the impact on biological/marine and agricultural resources is minimal.
- Both locations are the least impactful to the community by being at the very edge
 of town and down wind. With the new treatment technologies and processes we
 believe that little disruption will occur and with proper screening the facilities will
 truly be undetectable.
- 4. The proximity to the current WWTP and the current available easements for conveyance systems, make these the least expensive alternative for capital requirements, operational cost, and efficiency by consolidating the District's

- facilities. The current WWTP capacity has been determined to be adequate and any need for future growth is limited.
- 5. Site "A" has been offered for sale and site "X" is currently for sale, making these sites available, while honoring the landowners' rights.
- 6. Site "A" has some legal restrictions which need to be resolved, but we believe are worth some effort. Site "X" has some regulatory restrictions that will also need addressing, but again worth the review.
- 7. Both sites offer outstanding locations for phased recycled water and/or reclamation for direct ground water injection recharge. Assuming a continued low volume of brine from our RO plant, and the new WWTP can adequately assimilate and dilute this discharge, our need for an ocean outfall line could be eliminated, unless it is decided and approved for use by our neighbors to the South for their brine disposal.

After much discussion we believe trying to move the WWTP off site is not feasible. California State Parks does not have an adequate site for the project and both the Hearst Corporation, and the Ranchland Trust seem to have little interest in trying to accommodate it.

Historical experiences with Cambria indicate the difficulty, costs and timeline to join in a shared WWTP is not practical. Working with them on shared solutions for brine and other items of that nature are encouraged but delays and directional changes that have occurred in the past, raise concerns about our ability to meet our obligations with such a project.

We also believe that the other identified locations within the community would impact many more surrounding neighbors and be even more disruptive.


